BETWEEN: **HER MAJESTY THE QUEEN IN RIGHT OF CANADA** as represented by the federal Minister of Health, through the Public Health Agency of Canada (herein referred to as "Canada")

AND: **Middlesex-London Health Unit** (herein referred to as the "Recipient")

WHEREAS

Canada and the Recipient (herein referred to as the "Parties") entered into an Agreement that started on the 1st day of April, 2010 (herein referred to as the Agreement);

The Parties, by Amending Agreement # 1.1 dated on , amended the terms of the Agreement;

The Parties wish to further amend the terms of the Agreement in accordance with the provisions of this Amending Agreement; and

4.0 FINANCIAL CONTRIBUTION AND OBLIGATIONS

4.1 Subject to the terms of this Agreement, Canada will make a contribution to the Recipient of up to **Three Hundred Nine Thousand, Eight Hundred Sixty dollars (\$309,860.00)**. Canada's contribution shall be for Eligible Expenditures incurred by the Recipient in carrying out the Project in accordance with the Budget (Appendix B).

4.0 FINANCIAL CONTRIBUTION AND OBLIGATIONS

4.1 Subject to the terms of this Agreement, Canada will make a contribution to the Recipient of up to **Six Hundred Fourteen Thousand, Seven Hundred Twenty dollars (\$614,720.00)**. Canada's contribution shall be for Eligible Expenditures incurred by the Recipient in carrying out the Project in accordance with the Budget (Appendix B).

Except as amended herein, the terms of the Agreement remain in effect.

This Amending Agreement shall take effect upon the signature of all Parties.
