MEDICAL OFFICER OF HEALTH ACTIVITY REPORT FOR JULY

Recommendation

It is recommended that the Board of Health receive Report No. 034-20 re: "Medical Officer of Health Activity Report for July" for information.

The following report presents activities of the Medical Officer of Health (MOH) for the period June 6, 2020 to July 3, 2020.

The COVID-19 Pandemic continues to occupy the majority of the MOH's time. During the last week of June, Dr. Alex Summers, AMOH was seconded to Windsor Public Health to assist with the pandemic response there. The MOH stepped into some of the roles that were temporarily left vacant with this move.

The MOH continues to participate in many external pandemic related meetings each week. These include calls daily, every other day, or weekly with Middlesex County, the City of London, local health partners, the Association of Local Public Health Agencies (alPHa), the Ministry of Health, Ontario Health West, the Southwest LHIN, the Office of the Chief Medical Officer of Health, and Public Health Ontario, to name a few. The MOH and London Mayor Ed Holder continue to provide daily media briefings on the COVID-19 pandemic.

The MOH and the Associate Medical Officer of Health (AMOH) will continue to host a weekly all staff Town Hall throughout the summer weeks to present on many topics, including COVID-19.
