Surveillance Report

As of April 11th:

- Worldwide:
 - Over 497 million COVID-19 cases and over 6 million deaths have been reported
 - Over 11.2 billion vaccine doses administered worldwide
- In Ontario:
 - 1.19 million cases of this illness confirmed, including 12,566 deaths
- Locally:

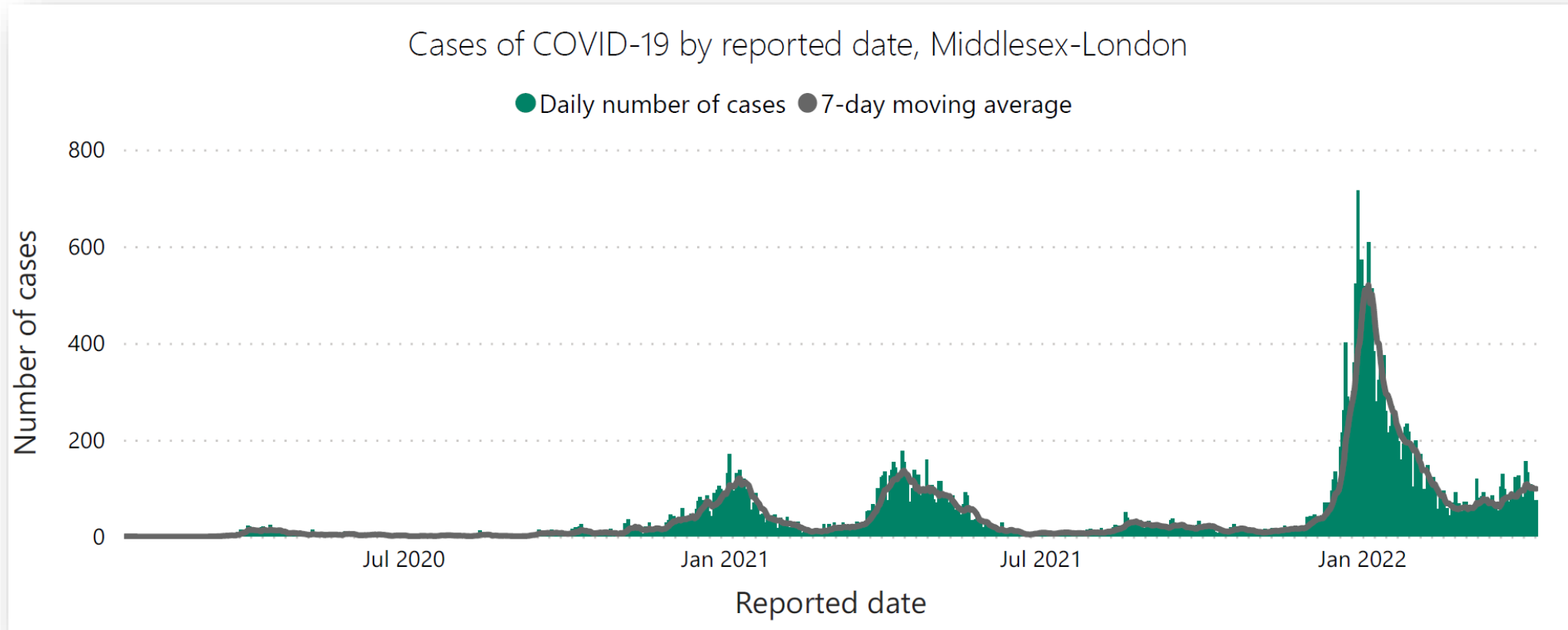

The risk of COVID-19 in our community is increasing

- With the end of mask mandate and the lifting of capacity limits, the current risk of COVID-19 transmission in Middlesex-London is very high.
- We are going to continue to see the number of COVID-19 cases increase.
- It is important to consider your risk for COVID-19 and take steps to protect yourself.
 - Wear a mask.
 - Ensure you are up to date for all recommended doses of COVID-19 vaccine, including a booster for those 12+ and a second booster for those 60+
 - Stay at home if you feel unwell or develop any symptoms of COVID-19
 - Consider limiting social interactions, and keeping social circles smaller, until there is less virus circulating in the community.

Maintaining safety in healthcare settings

- Masking continues to be a critical protection in healthcare settings.
- Other tools like symptom screening and physical distancing will also be helpful during the current COVID-19 wave.
- While balancing staffing pressures, it is critical that symptomatic staff have minimal patient interactions and stay home if they are sick.



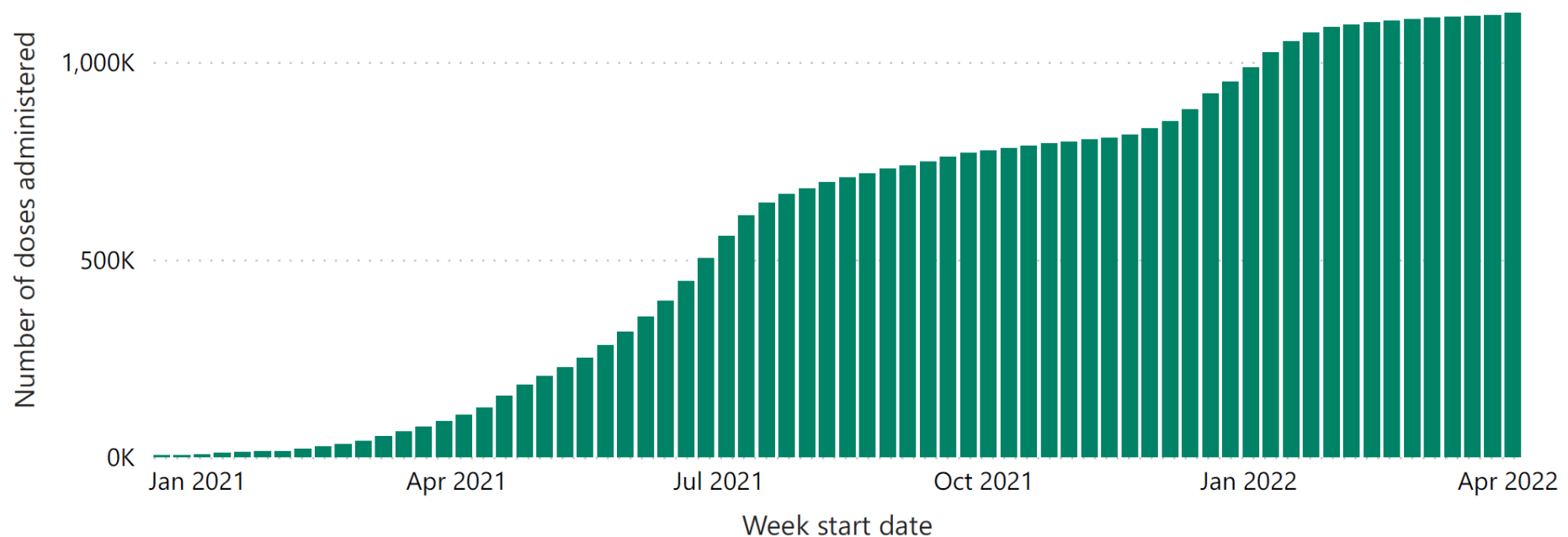

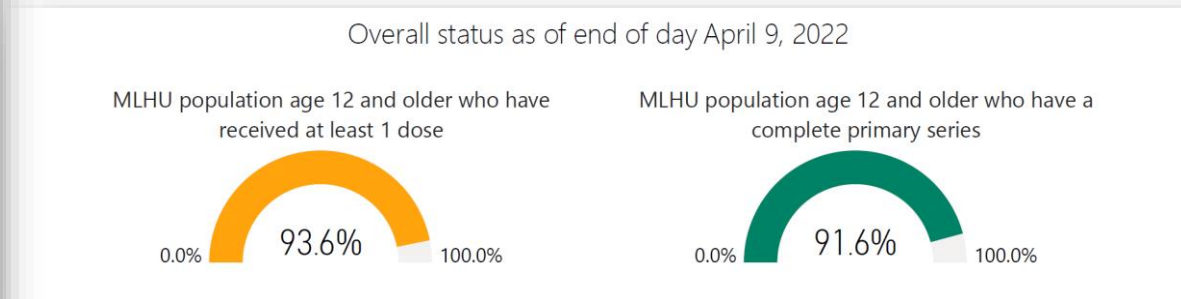
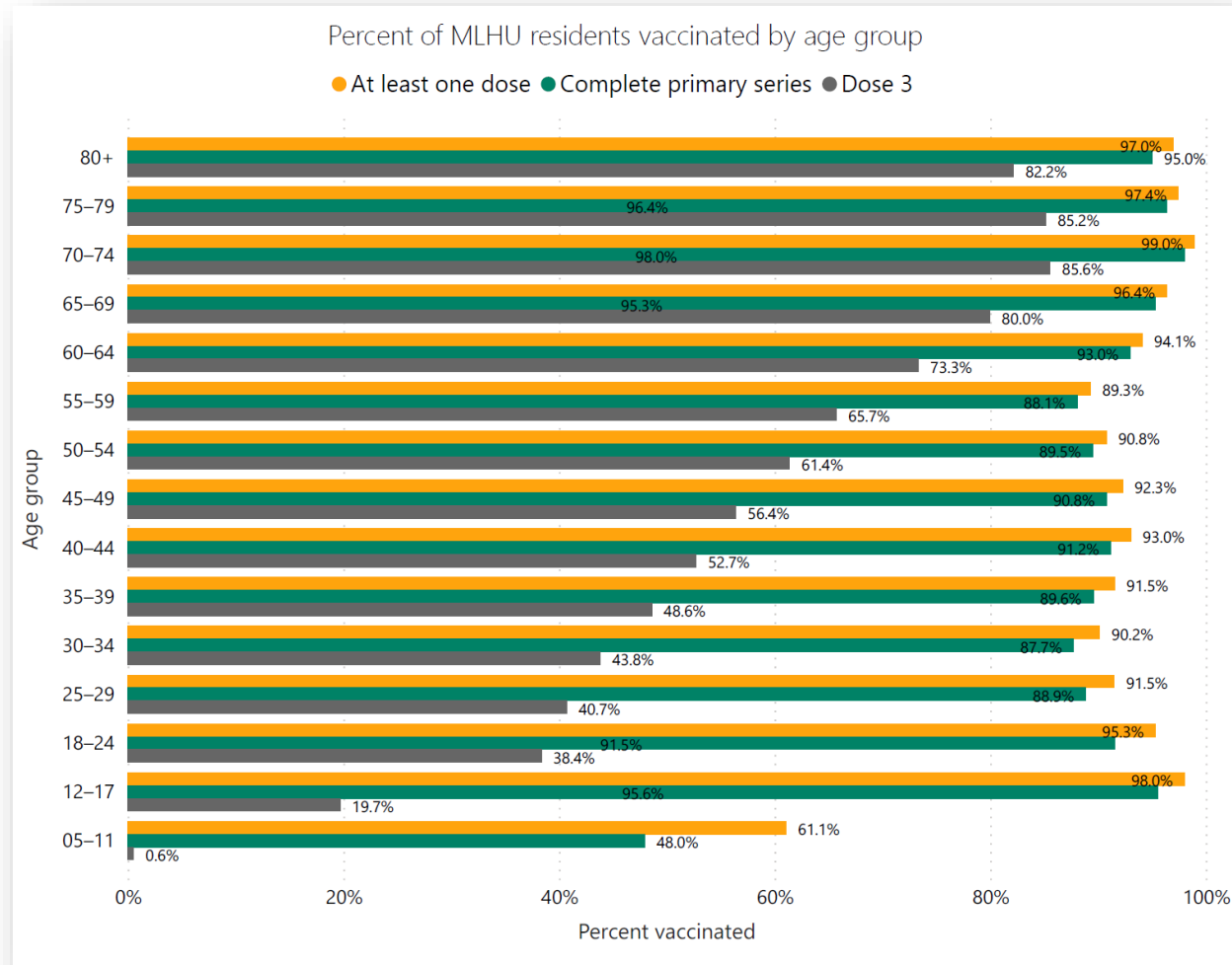

Expanded Eligibility for Second Booster (Fourth Dose)

- As of April 7th, eligibility has expanded for a second booster (fourth dose) of COVID-19 vaccine.
- Eligible groups include:
 - Adults 60 years of age and older
 - First Nations, Inuit and Métis populations who are 18 years of age and older (including non-Indigenous household members)
- Timing for a second booster (fourth dose) = 5 month interval (140) after first booster (third dose), with the option to receive a dose at a 3-month interval (84 days).
- MLHU website and booking site have been updated to reflect this change.

Provincial Update: New Eligibility to Assessing/Treating COVID-19

- Effective April 11th, the following groups are eligible to be tested and assessed for antiviral treatment, such as Paxlovid:
 - Individuals aged 18 and over who are immunocompromised (by a health condition or medications);
 - Individuals aged 70 and over;
 - Individuals aged 60 and over with fewer than three vaccine doses; and
 - Individuals aged 18 and over with fewer than three vaccine doses and at least one risk condition (e.g., a chronic medical condition)
- Ontario is also expanding dispensing locations to include participating pharmacies
 - A list of pharmacies that are dispensing Paxlovid will be available at [Ontario.ca/antivirals](https://ontario.ca/antivirals) as of Wednesday, April 13 at 8:00 a.m.

Update to Prescribing Paxlovid: Eligibility Criteria

- Reminder: Healthcare providers **can prescribe Paxlovid to eligible patients**
 - Confirmed* COVID-19 positive patient within **FIVE** (*previously three*) days of symptom onset who meets eligibility criteria can be prescribed treatment
 - *A positive rapid antigen test, PCR or rapid molecular test is required as part of the assessment for antiviral treatment.
- Paxlovid Prescription form is available online (link below), as well as through this week's newsletter
- Referrals can be made to Carling if unable to do testing (PCR OR Rapid Antigen Tests) in-office and/or can't see the patient in a timely manner
