## Family Planning and STI Sexual Health Clinics

The Middlesex-London Health Unit currently operates a Family Planning and Sexually Transmitted Infections (STI) Clinic located at 50 King Street, London, Ontario and a Sexual Health Clinic at 51 Front Street - Kenwick Mall, Strathroy, Ontario.

We are currently seeking a Physician for casual hours with availability to work Tuesday evenings and Thursday evenings (and possibly for other times) in our Sexual Health Clinics in London and/or Strathroy.

The Physician will consult primarily female clients at scheduled clinics both in London and Strathroy, Ontario. Responsibilities include:

- Assessing, diagnosing and treating sexually transmitted infections, prescribing birth control and facilitating the achievement and maintenance of sexual and reproductive health for the people in our community;
- Providing effective, client-centered, non-judgmental, confidential, easily accessible and affordable multidisciplinary clinical services;
- Contributing to the learning of current and future health care professionals in the areas of sexual and reproductive health through educational events, clinical placements and participation in relevant research.
- Physician should be skilled in IUD/IUS insertions and venipuncture.

### Qualifications include:

- Current registration with the College of Physicians and Surgeons of Ontario and Certification from the College of Family Physicians (CCFP), and/or Fellow of Royal College of Physicians and Surgeons of Canada (FRCPC).
- Appropriate coverage under the Canadian Medical Protective Association (CMPA) or comparable medical legal coverage
- A current knowledge of sexual health, including the diagnosis and management of sexually transmitted infections, and birth control methods
- Preference will be give to those with experience working in women's programs with a sexual health focus, or family practice settings managing sexual health issues
- At least three years experience in clinical practice. Teaching experience an asset
- Willing to practice within the policies and procedures established by the Middlesex-London Health Unit
- Excellent interpersonal, organizational, and communication skills
- Ability to work within an interdisciplinary team
- Able to work with vulnerable populations
- Very good computer skills
- The ability to communicate in French or other languages would be considered an asset
