ACCREDITATION – 2012 ANNUAL QUESTIONNAIRE AND SITE VISIT

Recommendation

It is recommended that Report No. 124-12 re "Accreditation – 2012 Annual Questionnaire and Site Visit" be received for information.

Annual Questionnaire

For the past two years, the Health Unit has been awarded Unconditional Accreditation from the Ontario Council on Community Health Accreditation (OCCHA), representing the highest level of achievement. The 2012 site visit represents the third and final visit in OCCHA's three year cycle, and the Board of Health will need to decide whether or not it wishes to pursue Accreditation again in 2013. The Health Unit completed and submitted the questionnaire to OCCHA on September 20, 2012 (attached as Appendix A). The questionnaire featured examples of projects completed in the past 12-24 months that demonstrated ongoing compliance with the OCCHA Standards. This included excellence in:
